YOU ARE HEREBY COMMANDED, en or before \_\_\_\_\_\_\_\_2000, (1) to immediately submit a report of waste discharge ("RWD") for water pollution associated with the Carnegie State Vehicular Recreation Area ("Carnegie SVRA") to the Central Valley Regional Water Quality Control Board ("Regional Board") pursuant to the Porter-Cologne Water Quality Control Act ("Porter-Cologne"), Water Code Section 13260 and (2) to immediately suspend all off-highway motor vehicle activity at the Carnegie SVRA, including vehicles driving in Corral

Hollow Creek as it flows through the Carnegie SVRA, until Respondents have submitted an RWD and received waste discharge requirements ("WDR") (or, to the extent it may be permissible, a conditioned waiver of such WDRs) from the Regional Board or, in the alternative, to show cause before this Court at the courtroom thereof at Oakland, California on 12/4, 2009, at 900 AM, why you have not done so.
